## Before Enrolling in MyCIC

Before you enrol in MyCIC, you must indicate if you have ever applied for a service (e.g. a study permit) electronically from Citizenship and Immigration Canada (CIC).

If you have applied before, then you will have a **Client Identification Number (Client ID)** (also called a Unique Client Identifier (UCI)). You can find your **Client ID** on any official document (including a work permit) issued by a Citizenship and Immigration Canada office, Case Processing Centre or Canadian visa office.

Your **Client ID** consists of four numbers, a hyphen (-) and four more numbers (example 000-1234-5678).

If you have never applied before, you will not have a Client ID.

If you have a Client Identification Number (**Client ID**) and you do not provide it, you will not be able to access MyCIC services.

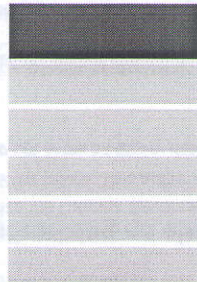
